TERMS OF MEMBERSHIP

APPROVAL OF MEMBERSHIP

All new memberships are subject to the approval of the Executive Board. Upon approval, membership becomes effective on the date of registration once approved.

MEMBERSHIP TYPES

ANREV offers two types of membership:

- Full membership is made available to institutional investors, fund and investment managers, investment banks, developers, consultants and related industry advisers
- Academic membership is available to not-for-profit research institutions, universities and professional bodies with interests in the non-listed real estate funds industry

Subsidiary and partner companies are not included under one group membership. Eg. A Fund of Funds organisation and a Fund Manager organisation under the same group would require two different memberships to access all member materials as well as exclusive investor-only benefits.

MEMBERSHIP ENTITLEMENTS AND BENEFITS

All memberships represent a corporate subscription with two designated representatives nominated by the joining corporation.

Membership is unlimited. All global employees of the named member organisation can access the member benefits on request.

VOTING RIGHTS & VOLUNTEER COMMITTEES

Members are entitled to vote at annual general meetings of the Association and are eligible to participate in the proceedings of the Executive Board, Research Committee, Professional Standards Committee, Performance Measurement Committee, Membership Committee and Events Committee as well as the Technology & Innovation Working Group and Debt Working Group.

INVESTOR ADVISORY BOARD

The Investor Advisory Board (IAB) is a body within ANREV to be controlled by investors. The IAB is established for institutional investors to improve and promote the development of the Asia non-listed real estate funds industry. The IAB provides a forum for institutional investors to discuss topical issues and provide strategic guidance for the working committees in closed-door discussions. Meetings of this nature are restricted to investor members to avoid possible conflicts of interest.

ANNUAL SUBSCRIPTION FEES

- Full Membership USD 10,000
- Academic Membership USD 500

PAYMENT METHOD

Once the Board has approved the membership, the applicant will be notified. An invoice will be sent within 30 days. Payment is due and payable in full, within 30 days of the invoice being issued. The invoice is recommended to be paid by bank transfer. If paid by cheque, a surcharge will be levied to cover additional costs. Credit card payments are also available using PayPal with a 3.00% transaction fee on top of the invoiced amount.

RENEWAL OF MEMBERSHIP

Membership is continued automatically every year unless written termination is received at least four weeks prior to the renewal date (December 31st each year).

CANCELLATION POLICY

Members wishing to cancel their subscription should do so in writing at least four weeks prior to their membership renewal date (31st December each year). A minimum of one full calendar year applies to all new members. Subscription fees are non-refundable. The cancellation is confirmed once the company has received written confirmation from ANREV. If a member does not comply with the Terms of Membership, the Executive Board can decide to suspend and then revoke membership.
